You grant StillSecure a perpetual, irrevocable, non-exclusive, worldwide, no-charge, royalty-free, transferable, license under all of your intellectual property rights relevant to the Contributions to make, have made, use, sell, offer to sell, import, copy, prepare derivative works of, publicly display, publicly perform and otherwise transfer your Contribution or derivative works thereof, in whole or in part, alone or in combination with, or included in, other products or works, and to sublicense these rights to third parties under open source licenses, the StillSecure Community License or any binary, proprietary or commercial license, through multiple levels of distribution or other licensing mechanisms, at StillSecure's option.
3. You understand that the decision to include the Contribution in the Project is entirely that of StillSecure and this Agreement does not guarantee that the Contributions will be included in the Project.
4. Except as set forth above, you retain all right, title and interest in and to your Contribution and may use your Contribution for your own purposes. The licenses granted above are effective on the date you first submitted a Contribution to the Project, even if the submission preceded the date of this Agreement. This Agreement shall be governed by the laws of the State of Colorado and applicable US federal law, without application of choice of law rules.

5. You represent that you have all the necessary rights to your Contribution and that you are legally entitled to grant the rights under this Agreement. You warrant that your Contribution, to the best of your knowledge, does not violate any other party's copyrights, trademarks, patents or other intellectual property rights. If your employer could claim rights to intellectual property that you created, you represent that you have received permission to make the Contributions on behalf of that employer or that your employer has waived any rights to the Contributions.

6. You must deliver to StillSecure an electronic copy of all source code to any Contributions prior to your distribution of the modified Cobia code.
